### **Training- 12-13 OCTOBER 2018** Embassy Café, Timisoara

The training took place between 12-13 October 2018 in Timisoara, at the Embassy Café, a place where immigrants and non-governmental organizations carry out various cultural accommodation activities and events.

Our partner was Aidrom Timisoara, an organization which supports asylum seekers, refugees and migrants from Romania through social counseling, material assistance, medical services, romanian language courses and cultural accommodation.

At this course attended 20 people from 7 different countries: Syria, Irak, Egipt, Afganistan, Saudi Arabia, Yemen and Germany, some of them being students, others refugees in Romania.



The following topics were discussed during the two days of the course:

- 1. Human Rights; Multiculturalism and intercultural exchange;
- 2. Aspects of legal order importance of criminal law in the process of integration and prevention of radicalization; Models of integration

#### 1. Multiculturalism and intercultural exchange;

This session was supported by FLAVIUS ILIONI - LOGA, from AIDROM Timisoara partner with C.P.I.P. in this project, which highlighted the essential aspects related to this topic, based strictly on the personal and professional experience gained in its work with migrants.

We talked about the ideas, customs and social behavior of a particular people or society, promoting intercultural exchange.

The learners were impressed by the way information was transmitted, cooperated and asked questions.

#### 2. International Human Rights & Human Rights Defenders

An extremely important aspect of this project, about fundamental human rights, was presented by AMALIA TARAN, specialist in legal issues and legislation related to the migratory phenomenon and trainer within this project, from C.P.I.P. Timisoara. In the presentations we discussed about the historical perspective on human rights, important documents; examples of human rights defenders; explaining the significance of human rights for the functioning of a democratic society.

The presentation was also well anchored in the life of the migrant in Romania and managed to create a series of debates, desirable and useful to the purpose and objectives of the project.

1. Aspects of legal order- importance of criminal law in the process of integration and prevention of radicalization;

Preventing radicalization, on the one hand and victimization among migrants, on the other hand, are essential aspects of the project. This topic was presented by Mr. FLORIN BACIOIU, trainer at C.P.I.P. Timisoara.

The need to know of a migrant is very high, especially when it comes to the legislation of the host country and through this project it is also desirable to cover this area, especially since many of the Romanian legal provisions differ from those in their countries of origin.







### 2. Models of integration;

A specialist with old states in this field, Mr. FLAVIUS ILIONI - LOGA, from AIDROM Timisoara, gave a captivating presentation with a permanent interaction with the audience, managing the extraction of the most important ideas related to the process and the integration capacity of migrants.













At the end of each course day, the trainer and trainees had the opportunity to socialize and discuss in a less formal setting, around oriental style snaks.









Demographic changes indicate Europe's evolution towards an inter-ethnic, interreligious and intercultural society.

Policies should promote a harmonious development in terms of equal rights and solidarity for all members of the community, avoiding discrimination and exclusion that could lead to tensions and violence.

A key component of demographic change is the migration of predominantly Muslims and this trend seems to remain a constant one.

#### The challenge

The challenge is to address migrants who they are in various situations, for example: educational institutions, social protection centers or prisons.

**REM** aims is to improve the knowledge and skills of organizations and institutions dealing with migrants in these situations so that they become an area for promoting integration, intercultural dialogue and taking responsibility for democratic values and human rights, while eliminating segregation, exclusion, stigmatization and radicalism.
