# MINDb4ACT: Innovative, ethical and effective actions to tackle radicalization leading to violent extremism

- This project has received **funding** from the European Union's Horizon 2020 Research and Innovation Programme Grant Agreement No 740543
- Its **aim** is to develop a comprehensive approach to violent radicalization in the EU from early understanding to improving protection.
- **Duration:** September 2017 August 2020.
- Consortium partners: Project coordinator is Real Instituto Elcano (Madrid, Spain) with a consortium consisting of 18 partners from 10 European countries.

**Priority 1.** Systematizing the available knowledge and expertise to support strategic decision-making

**Priority 2.** Enhancing interdisciplinary fieldwork on terrorists' recruiting grounds, socialisation and techniques

**Priority 3.** Using big data in order to analyse the information related to the communication practices of violent radicalisation

**Priority 4.** Improving existing links between academia including non-EU researchers, policy-makers and other stakeholders

- 7 agencies + security forces from 5 countries
- The Project intends to be useful for the stakeholders involved with prevention policies. To do so, it will use scientific evidences and research results to develop 21 pilot projects in 5 prioritary areas for violent radicalization: schools, prisons, detention centers of migrants and asylum seekers, urban areas and communication and internet contexts. The evaluation of these Project will be used as a criteria to wether incorpórate them or not to National strategies of member states.
- The Project will also develop:
  - 6 scientific missions
  - A scientific paper on the process of radicalization and an evaluation on rehabilitation practices
  - Impact analysis of mass media and internet
  - Psycosocial analysis of self-radicalization
  - A macro-survey for stakeholders
  - An analysis on how intelligence forces are evaluating the problema
  - An online network of interested stakeholders
  - Training courses for professionals

PETYRE Project is a Training Course for Youth Workers that aims at tackling Youth Radicalization and Extremisms through:

- PREVENTION STRATEGIES
- SOCIAL COHESION
- INTERCULTURAL DIALOGUE

#### **MAIN OBJECTIVES**

- To raise awareness about youth radicalization and analyze causes and recruitment strategies
- To provide participants with knowledge, tools and competences to prevent and tackle youth extremism (i.e. Conflict resolutions, dialogue facilitation, counter narratives, etc.)
- To learn and test young-person centered approach in designing educative methodologies
- To promote cooperation between youth organizations and other relevant stakeholders on this topic.

#### **METHODOLOGY**

All the Activity Program has been implemented through <u>non-formal</u> <u>education</u> and learning by doing methods.

Participants have been provided with theoretical knowledge and got familiar with innovative tools, methodologies and strategic interventions.

### **Good Practice**

### Strong Cities Network

- The SCN is made up of mayors, municipal-level policy makers and practitioners united in building social cohesion and community resilience against violent extremism in all its forms.
- The global network is currently made up of more than 100 cities. Membership is completely free of charge. Malaga is the only Spanish one so far.
- Facilitate systematic sharing of knowledge, expertise and lessons learned on building social cohesion and community resilience to prevent violent extremism across cities on an international basis, through both regional workshops and international conferences.

- Raise awareness of existing policy, programming, and practice through a dynamic and searchable 'Online Information Hub', providing an extensive library of existing local approaches and responses to prevent violent extremism.

- Directly support cities to develop strategic frameworks and capabilities to build resilience that safeguard the rights of their local communities, including through capacity building seminars and interactive training modules on themes of mutual interest.

# Relevant practices regarding integration and intercultural dialogue

Manual for preventing and detecting racism, xenophobia and other forms of intolerance in the classroom – FRIDA PROJECT

# Conclusions

- Funding difficulties except for European programmes.
- Spain has got a limited expertise regarding: terrorism and radicalization but also integration and diversity management.
- Many misconceptions and misunderstandings regarding programmes and policy-making when it comes to Muslim community.
- Preventing exclusion and discrimination seems essential to prevent radicalization and extremism.
- Civil Society entities and public institutions seem to have very different approaches, especially those involving security forces. An approach based on interculturality, active citizenship, equality and a human rights perspective seems essential at the moment.
